



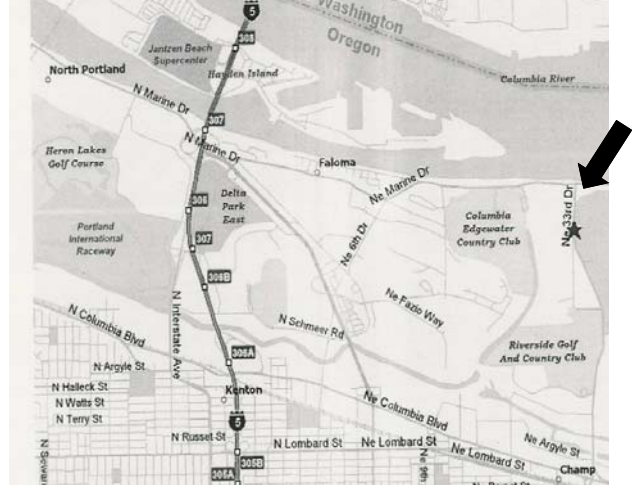
# Dolls, Teddy Bears & More Show & Sale

**Kliever National Guard Armory - Marine Dr at 33rd Dr - Portland, OR**

Exit #307 off of I-5, follow signs to Marine Dr East, stay on Marine Drive for 1.5 mile. Turn right on NE 33RD Dr

- Tables are \$75. each (**7 ft. x 32 inches**). No space will be held without a completed contract & deposit.
- Set up time is Friday 12PM to 6PM and Sat 7AM to 8:30AM
- Display Rules: Table covers are required, no general sale signs, all signs must be in good taste, all merchandise must be priced, and the exhibit must stay within the contracted space.
- Dealers will not start packing before 4:00PM Saturday.
- Table locations are assigned by seniority and date of contract received. First priority is given to dealers who pay by the end of the previous show.
- Subletting of tables and floor selling are not allowed.
- Smoking is not allowed in the exhibit hall. No pets are allowed, except guide dogs.
- Dealers are responsible for any loss or damage to their own merchandise and will hold harmless Dolls4all and the Kliever National Guard Armory.
- There will be a \$25.00 charge for all returned checks. A \$15.00 late fee will be charged to payments received after the due date.
- Cancellation Policy: Payments are not refundable. Cancellations are credited to a future show. No credit is given for cancellations within a week prior to the show set-up date
- Dry camp RV parking is available.
