

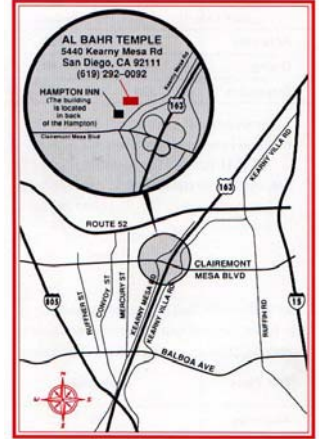

- Table locations are assigned at the sole discretion of the promoter
- Set up time is Sunday 7AM to 9:30AM. Dealers who have not checked in by 9AM will forfeit with no refund.
- Display Rules: **TABLES ARE 6' x 30"**, undraped. Table covers are required. No general sale signs, all signs must be in good taste, all merchandise must be priced, and the exhibit must stay within the contracted space.
- Dealers will not start packing before 4:00PM Sunday. Subletting of tables and floor selling are not allowed.
- Smoking is not allowed in the exhibit hall. No pets are allowed, except guide dogs.
- Dealers are responsible for any loss or damage to their own merchandise and will hold harmless Dolls4all and the Sheraton Mission Valley.
- Cancellation Policy: Payments are not refundable. Cancellations are credited to a future show. No credit is given for cancellations within a week prior to the show set-up date
